Sanction is hereby accorded to reconstitute the Lead Agency by superseding notification No. 1/11/2016-4GSII, dated 08.09.2016 to act as the 'Secretariat of the State Road Safety Council' and coordinate all activities relating to road safety in the State, which would include the functions of the Police, Public Works (B&R) Department, Education Department, Health Department, Local Bodies, Non-Government Organization and other departments concerned with Road Safety.

1. The Secretariat will be established in the office of Transport Commissioner and Additional Transport Commissioner (Road Safety) will be the Head of Lead Agency. The Secretariat will function independently under the overall control, supervision and monitoring of Transport Commissioner-cum Secretary/Special Secretary, Transport Department, Haryana and comprise of following full time Officers/Members to be drawn from the department indicated against each:

1.	Head of Lead Agency	Additional Transport Commissioner (Road Safety) to be

2.	Member	A Superintending Engineer level officer, to be deputed by the PWD (B&R).
3.	Member	A Sub Divisional Engineer level officer, with the qualification of Civil Engineer to be deputed by the Urban Local Bodies or on deputation from PWD (B&R).
4.	Member	A Deputy Superintendent of Police level officer, to be deputed by the Home Department.
5.	Member	A Deputy Director level Officer, to be deputed by the Health Department.
6.	Member	A Deputy Director Level Officer, to be deputed by the Education Department.
7.	Member	Statistical officer to be deputed by the Planning Department.
8.	Member	Motor Vehicle Officer (MVO) to be deputed by the Transport Department(Regulatory Wing)
9.	Member	A person from Non-Government Organization/Institutes engaged in the field of Road Safely, to be nominated by Transport Department.
10.	Under Secretary	Publicity Officer (Road Safety) to be deputed by the Transport Department.

2. (a). The salaries of officials/member drawn from concerned departments to perform work of lead Agency shall be paid by their parent departments.

- (b). The post of Additional Transport Commissioner (Road Safety) will be filled by a regular IAS/HCS officer or by re-employment of retired IAS/HCS officers who is less than 65 years of age, as per state guidelines/rules on re-employment.
- (c). In case Additional posts, are required to perform the work of lead Agency, the Transport Department shall initiate proposal to create such posts.
